You (or a coauthor) will register at the conference and at the workshop (deadline for reduced fee is 15 June 2000) and will present the paper at the workshop.

The style of the final paper is identical to the submission style, except the final paper has **NO PAGE NUMBERS**. Please remove the `\ecaisubmission` command if you are using LaTeX.

**Full papers** are allocated **SIX** (6) pages, **position papers** are allocated **THREE** (3) pages in the workshop proceedings. We will not include your paper in the workshop proceedings if it is longer.

Please note the June 1, 2000 deadline for submission of camera-ready, digital version. This is a firm, fixed deadline, and late papers may not be included in the workshop proceedings.
